The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

COVID-19 RULES - BTCA National Specialty, Sweepstakes, Futurity, Jr. Showmanship & Isis Vabo & Silverwood

1. The shows will be closed to the general public. Anyone attending the shows must either be an owner, exhibitor, handler, handler assistant, judge, club members or any hired professionals (photo, video, superintendents, stewards, etc.). Any family members or friends attending the show must enter with an owner or handler of the dog (first time entering) and get an access pass.

2. **Masks will be required (not face shields)** in all buildings and vendor booths at all times. Exhibitors, owners, breeders, handlers, assistants and approved guests will be required to provide their own masks.

3. Obedience & Rally Events are included in the facemask rule.

4. The ring will have a connected Ready Rings and ringside crating area.

Crates are only allowed in crating area 15 minutes before and after breed judging. The rings will also be marked every six (6) feet so when lining up everyone can still adhere to social distancing. This means classes may be divided to allow for adherence with social distancing.

5. Indoor grooming space will be marked off to follow social distancing guidelines and is available on a first come, first serve basis. Exhibitors grooming indoors will be expected to stay within the designated grooming area and use the same space throughout all events. There is ample outdoor space for grooming setups adjacent to the Kern Pavilion. Please observe social distancing when setting up grooming space in either location. No forced air dryers allowed inside the pavilion. 6. Site Control from the city of Frankenmuth will be at the show. Please follow all of Site Controls directions etc.

7. PLEASE BRING WHAT YOU NEED TO KEEP YOUR DOGS COOL OR WARM! We understand that Michigan has very unpredictable and changeable weather. It could be warm (not likely) or it could be snowing and windy. The roll up doors will be open as weather permits. Having the ability to have the doors open will dictate how many people are allowed in the building at one time.

Michigan State mandates as well as county and city will govern these variables.

8. We will have signs through out the buildings and grounds to help with reminding people of the rules, safety measures and to work together. Please observe all signs especially one pertaining to entrance and exit doors on the building.

9. Every entrance, in or out, of the Buildings will have hand sensitizer stations with signage. Judges will have hand sanitizer and will sanitize their hands after judging every dog.

10. Entries do not Open until August 19, 2020 at 12:00 pm with a closing date of September 30, 2020, 6:00 PM PDT.

11. We are still working out other processes and procedures like obtaining Arm Band numbers and all people attending will need an access pass and many others. We will post final list and send it out with the judging programs.

12. Failure to adhere to these rules or requests by show personnel, staff or government personnel will result in a bench hearing automatically.
